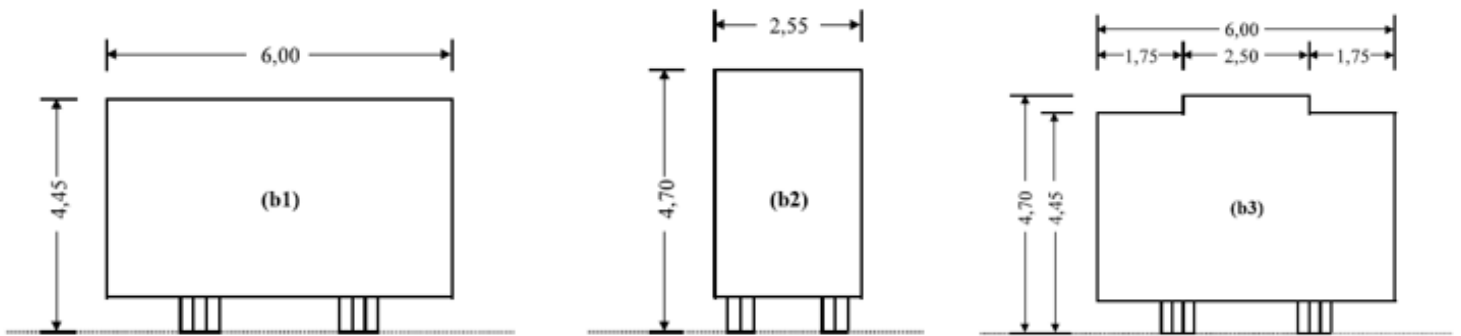

PAPERS THAT YOU NEED TO PROVIDE IN SUPPORT OF YOUR REQUEST FORM:

- Photocopy of the tractor (s)registration certificate;
- In case of B3 type convoy, it is mandatory to provide the longitudinal, transversal, and planimetric graphical layout reproducing (**one graphical layout for each vehicle/additional convoy must be provided**):
 1. The vehicle's configuration or combination with its load;
 2. The size and the clearance height of the load from the ground in case of lateral protrusions;
 3. The total mass and distribution over the axles;
 4. The distance between consecutive axles and the distance between the last axle of the tractor and the first axle of the trailer/semi-trailer;
- Crossing Authorization issued by ATMB (if the crossing is from Italy to France);
- Crossing Authorization issued by ANAS/RAV (if the crossing is from France to Italy);
- An affidavit (if the maximum weight authorized by the Italian traffic regulations is exceeded) signed by the legal representative or his delegate, certifying the weight and the size of the load as well as the route concerned by the transit. The affidavit is made in compliance with Article 47 of Italian Presidential Decree No. 445/2000, expressly referring to the penal sanctions set forth in Article 76 of the Italian Presidential decree in case of false declarations;
- A declaration of honor according to French regulations on overloading compared to what is set out in French traffic regulations.



USEFUL INFORMATION AND INSTRUCTIONS:

Convoys arriving at the Mont Blanc Tunnel from France to Italy and not followed by an ATMB escort convoy must stop at the Passy Regulation Area.

For all convoys exceeding 3.5 meters width and/or 94 tonnes and/or 25 meters in length:

It is mandatory to contact the ATMB Autoroute PC at least 72 hours before the intended date of crossing to organize the escort. Phone number: (+33) 04 50 07 29 29.

The access to the Mont Blanc Tunnel will be granted only after ATMB's request acceptance.

For all convoys exceeding 44 tonnes and coming from Italy, the access to the Mont Blanc Tunnel ramp is regulated as follows:

At the exit of Courmayeur Sud, the driver of the convoy shall call at the following number 0165.89.04.11 the PCC to inform about his imminent arrival, in order to manage the passage on the Mont Blanc Tunnel access ramp.

Purposes: Management of the contract and of the relevant tax obligations.
